



**By signing this legally binding document I acknowledge the risks associated with surfing and understand that injuries may occur during participation at Surf Sessions.** I understand that there are inherent risks involved in the sport of surfing and that injuries are a normal and ordinary occurrence, and I freely assume those risks. Surfing is a dangerous sport with hazards such as rocks, reef, ocean currents, other surfers, and equipment. I fully recognize such hazards and understand the nature and existence of inherent risks. In the event of injury to my child, dependent, or myself, I hereby release Surf Sessions, its owners, employees, partners, and sponsors from any and all liability claims or personal injury claims, including accidental death. Further, I release the City of San Diego, the City of Del Mar, the City of Carlsbad, the City of Encinitas, the State of California and their officials and employees from any and all liability claims for personal injury, including accidental death, or property damage. In the event that I cannot be reached in a medical emergency, I hereby grant permission to provide emergency care and secure proper treatment for my child, my dependent, or myself.

**Photo & Video Release:** By signing this, you irrevocably grant to Surf Sessions perpetually, exclusively, and for all media throughout the world, the right to use and incorporate, in whole or in part, photographs or video footage taken of you as a result of participation in Surf Sessions for use by Surf Sessions and its sponsors, partners, clients, and participants, at the discretion of Surf Sessions. All images and video footage taken, as a result of participation in Surf Sessions, will become the sole property of Surf Sessions.

**Transportation Release:** I hereby give permission to authorized representatives of Surf Sessions and contracted drivers to provide transportation in an authorized vehicle for my child to be transported to and from camp, and to participate in camp activities. I do hereby indemnify and agree to hold harmless Surf Sessions, and its administrators, employees, and persons transporting my child for any claim arising out of any injury or incident in the course of providing transportation for my child.

**Payment Terms:** By signing below I verify that I understand the payment terms and understand that fees outlined below will apply should I decide or need to cancel or reschedule.

**Cancellations with over 90 days advanced notice:**

\$300 cancellation fee is charged and is non-refundable and non-transferable to another session, per individual participant for each individual session. In the case that you have registered for multiple sessions, each individual camp registration (regularly valued at \$1095) will be assessed the \$300 cancellation fee.

**Cancellations with 60-89 days advance notice:**

\$600 cancellation fee is charged and is non-refundable and non-transferable to another session, per individual participant for each individual session. In the case that you have registered for multiple sessions, each individual camp registration (regularly valued at \$1095) will be assessed the \$600 cancellation fee.

**Cancellations with less than 60 days advance notice:**

No refund will be issued and the total amount charged for your session is non-refundable and non-transferable. If you cancel with less than 30 days advance notice, you will not receive any refund or credit.

**Dismissal From Camp:**

I understand that it is my responsibility as the parent or guardian to inform the camper of all rules before attending Surf Sessions. In the event that the Surf Sessions director determines that my child or dependant is causing a risk to him or herself or others, the parent(s) or guardian(s) will be responsible for immediately removing the child from camp or making immediate arrangements for the child's return home. In the case that my child is dismissed, I understand that I will not receive a refund or credit of any kind and that I will bear the burden of any additional expenses or inconvenience this may cause. I also understand that my child or dependant may be dismissed from camp for negatively impacting the experience of other campers or causing an unreasonable or disproportionate burden on staff. All dismissal decisions are made at the discretion of the Surf Sessions director, Uriah Mirandon, and will be solely based on his judgment of the situation.

**By signing this Release Form, I attest to reading it in full, and completely understand and agree to its terms. I also understand that if my child participates in multiple Surf Sessions programs and activities that this release form applies to all Surf Sessions programs that occur between the date signed and Aug 31, 2013.**
